## ORDER DENYING PETITION FOR DISCRETIONARY REVIEW

This is a fisheries enforcement matter in which Respondent was charged with a violation of the Magnuson-Stevens Fishery Conservation and Management Act (MSFCMA), 16 U.S.C. §§ 1801-1883. On May 14, 2008, the National Oceanic and Atmospheric Administration (NOAA) issued a Notice of Violation and Assessment (NOVA) to Respondent Pesca Azteca, S.A. de C.V., owner of the F/V AZTECA 1. Respondent was charged with unauthorized foreign fishing within the Exclusive Economic Zone of the United States, in violation of Section 307 of the MSFCMA, 16 U.S.C. § 1857(2)(B).

After a hearing on July 7, 2009, an Administrative Law Judge (ALJ) issued an Initial Decision in this case on October 1, 2009, finding for the Agency and assessing a \$130,000 civil penalty and a five-year permit sanction. Respondent filed a Petition for Discretionary Review on October 30, 2009.

Pursuant to 15 C.F.R. § 904.273, Respondent's petition for discretionary review is denied because Respondent has not demonstrated that the ALJ's Initial Decision warrants further review.

This Order denying discretionary review constitutes the final administrative decision in this matter. The civil penalty and permit sanction imposed by the ALJ will become final on the date this Order is served on Respondent, and they will become effective for the purpose of judicial review on the date of service.
