Enforcement Actions
July 1, 2015, through December 31, 2015¹**

NOVA and/or NOPS and/or Written Warning Issued and Served²

During this time period, NOAA charged 33 civil administrative cases, as follows:³

ALASKA

1. AK1102634A; F/V Alliance - Operator was charged in two counts under the Magnuson-Stevens Fishery Conservation and Management Act (Magnuson-Stevens Act) for harassing observers by conduct that had the effect of interfering with the observers' work performance. A \$30,000 NOVA was issued. [See, Settled cases, item 2, below, for resolution of this matter.]
2. AK1102634B; United States Seafoods LLC and Alaska Alliance LLC - Companies were charged under the Magnuson-Stevens Act for negligently supervising an employee and the operator of the F/V Alliance, who harassed an observer by conduct that had the effect of interfering with the observer's work performance. A \$30,000 NOVA was issued. [See, Settled cases, item 3, below, for resolution of this matter.]
3. AK1201797 - Individuals were charged in two counts under the Marine Mammal Protection Act for taking a beluga whale in a wasteful manner, only harvesting the fins and tail, resulting in the waste of a substantial portion of the marine mammal; and for taking a beluga whale in a wasteful manner, only harvesting the fins and/or tail and a portion of blubber from the whale, resulting in the waste of a substantial portion of the marine mammal. An \$8,000 NOVA was issued.
4. AK1300421; F/V Nature - Owners and operator were charged under the Magnuson-Stevens Act for directed fishing for Pacific cod using longline gear within the 10nm closed area for Pacific cod using longline gear off of Marmot Island in the Gulf of Alaska. A \$9,873.84 NOVA was issued.

AK1401072; F/V Leslie Lee - Owner and operator were charged under the Magnuson-Stevens Act for submitting inaccurate information to the NMFS by reporting on an Alaska Department of Fish & Game fish ticket that the operator harvested Pollock in statistical area 640 when the operator actually harvested it in statistical area 630. A \$17,500 NOVA was issued.
6. AK1401073; F/V Marathon - Owner and operator were charged under the Magnuson-Stevens Act for submitting inaccurate information to the NMFS by reporting on an Alaska Department of Fish & Game fish ticket that the operator harvested Pollock in statistical area 640 when the operator actually harvested it in statistical area 630. A \$17,500 NOVA was issued.
7. AK1501220; F/V Buccaneer - Operator and company were charged in two counts under the Northern Pacific Halibut Act (Halibut Act) for retaining undersized halibut; and for making an Individual Fishing Quota (IFQ) halibut landing other than directly to a registered buyer. A \$21,000 NOVA was issued.
8. AK1501305; Graham & Rollins, Inc. and Hampton Seafood Market & Restaurant - Individuals and companies were charged under the Halibut Act for offering for sale Pacific halibut caught by sport fishing at Hampton Seafood Market & Restaurant. A \$4,000 NOVA was issued. [See, Settled cases, item 8, below, for resolution of this matter.]
9. AK1502232; F/V Rascal - Owner/operator was charged in two counts under the Halibut Act for taking and possessing undersized halibut; and for making an IFQ halibut landing other than directly to (or by) a registered buyer. An \$8,584.30 NOVA was issued.
10. AK1502314; Alaska Adventures, LC - Company and individual were charged under the Halibut Act for engaging in a guided charter halibut fishing trip with charter vessel anglers on board in regulatory area 2C without an original valid charter halibut permit for the regulatory area in which the vessel was operating. An \$8,000 NOVA was issued.

11. NE1400744; F/V Warrior - Owner and operator were charged in two counts under the Magnuson-Stevens Act for entering and fishing in an area closed to fishing -- Closed Area II; and for failing to comply with Vessel Monitoring System (VMS) reporting requirements. A \$39,360 NOVA was issued.

NE1402820; F/V For-2-Na - Owner/operator was charged under the Magnuson-Stevens Act for catching and retaining an Atlantic highly migratory species (HMS) -- Atlantic Bluefin tuna -- without a Federal permit to do so. A \$6,361.55 NOVA was issued. Owner/operator was charged under the Magnuson-Stevens Act for possessing and landing two different sized Atlantic Bluefin tuna caught on the same fishing trip. of State law -- Maine law. A \$41,000 NOVA was issued. [See, Settled cases, item 16, below, for resolution of this matter.]

14. NE1500204; Massachusetts state registered vessel Maggie May - Owner/operator was charged under the Atlantic Striped Bass Conservation Act for possessing one Atlantic Striped Bass in the Exclusive Economic Zone (EEZ) of the Atlantic Ocean. A \$500 NOVA was issued. [See, Settled cases, item 17, below, for resolution of this matter.]
15. NE1500921; F/V Capt. Kenny - Owner and operator were charged under the Magnuson-Stevens Act for failing to comply with regulations governing crew size in the Atlantic sea scallop fishery. A \$17,495 NOVA was issued.

16. NW1403457; cruise ship Regatta - Owner and operator were charged under the National Marine Sanctuaries Act for discharging or depositing, from within or into the Olympic Coast National Marine Sanctuary, any materials or other matter from the cruise ship. A written warning was issued.

NW1403730 - Individual was charged under the Magnuson-Stevens Act for harassing an observer by conduct that had sexual connotations, had the purpose or effect of interfering with the observer's work performance, and/or otherwise created an intimidating, hostile, or offensive environment aboard the F/V American Triumph. A written warning was issued.

NW1501410; F/V Jaka - Owner and operator were charged in three counts under the Magnuson-Stevens Act for interfering with or biasing the sampling procedure employed by an observer, including discharging catch before sampling; for requiring, pressuring, coercing, or threatening an observer to perform duties normally performed by crew members, including sorting the catch; and for failing to meet the vessel responsibilities, by failing to provide all reasonable assistance to enable the observer on board the vessel to carry out the observer's duties, including collecting bycatch when requested by the observer, and collecting and carrying baskets of fish when requested by the observer. SE1500600; F/V J.U.M.A. - Owner and operator were charged in two counts under the Magnuson-Stevens Act for using or possessing prohibited gear, i.e., possessing more than 1,000 hooks aboard a vessel issued a bottom longline (BLL) endorsement that is fishing with BLL for reef fish; and for failing to maintain fish intact through offloading ashore.
