NOAA Office of General Counsel, Enforcement Section Enforcement Actions July 1, 2019 through December 31, 2019 ¹

During this reporting period, NOAA charged 69 civil administrative cases, settled 65 civil administrative cases, and otherwise resolved three written warnings and three additional civil administrative cases upon default.²

A \$2,000 NOVA was issued.
- 2. AK1704676A Owner True Alaskan Charters, LLC and charter vessel guide Robert Lachester were charged jointly and severally under the Northern Pacific Halibut Act with failing to submit logbook pages to ADF&G as required by federal regulation. A \$3,000 NOVA was issued and the case settled for \$2,700.

AK1704676B Owner True Alaskan Charters, LLC and charter vessel guide Richard Gaiser were charged jointly and severally under the Northern Pacific Halibut Act with failing to submit logbook pages to ADF&G as required by federal regulation. AK1802383A Owner Wahl Fisheries, LLC and Operator William Wahl were charged jointly and severally under the Magnuson-Stevens Fishery Conservation and Management Act (Magnuson-Stevens Act) with retaining individual fishing quota (IFQ) sablefish in excess of the IFQ held by all permit holders aboard for the area in which the vessel was deploying fixed gear. A \$5,750 NOVA was issued and the case settled for \$5,175.

AK1804443 Owner Hat LLC and operator Jon Andrew Greenway were charged jointly and severally under the Northern Pacific Halibut Act with failing to maintain an accurate log of Pacific halibut fishing operations while fishing in waters in and off Alaska. A \$2,200 NOVA was issued and the case settled for \$1,980.
- 8. AK1806496A Owner Bristol Leader Fisheries LLC, manager Alaskan Leader Fisheries LLC, and chief engineer Curtis Foster were charged jointly and severally under the Magnuson-Stevens Act with eight counts of flow scale tampering. A \$191,773 NOVA was issued.

AK1902785 Owner Sylver Fishing Company and operator Sylvia Ettefagh were charged jointly and severally under the Northern Pacific Halibut Act with failing to continuously and completely offload at a single offload site all halibut onboard, and for submitting an inaccurate statement. A \$17,600 NOVA was issued and the case settled for \$15,840. The proceeds of the violation (\$3,189.50) were forfeited.

A \$34,000 NOVA was issued.
