- NE1905466; F/V Rock On Owner/Operator Gregory Ares was charged under the Magnuson-Stevens Fishery Conservation and Management Act (Magnuson-Stevens Act) and the Atlantic Tunas Convention Act with failing to report Atlantic bluefin tuna. A \$4,750 NOVA was issued.
- 2. NE2005670; F/V Tyler Putney Owner/Operator Tyler Putney was charged under the Magnuson-Stevens Act with failing to report Atlantic bluefin tuna landed within twenty-four hours on twenty-four different occasions between September 2, 2018 and October 6, 2020. A \$6,500 NOVA was issued.
- 3. NE2000750; F/V Skipper Owner/Operator William M. Briggs was charged under the Magnuson-Stevens Act with failing to comply with vessel trip report requirements by not listing landings of winter flounder. A \$3,000 NOVA was issued.
- 4. NE2006469; F/V Romans Road Owner/Operator Corydan E. Hawkes was charged under the Magnuson-Stevens Act with fishing inside Canadian waters without authorization. A \$4,750 NOVA was issued.

A \$75,000 NOVA was issued.

- AK1906825; F/V Cameron Owner Overa Fisheries, LLC and Operator Roger Overa were charged jointly and severally under the Magnuson-Stevens Act with operating a vessel in the Gulf of Alaska Pacific cod fishery without carrying an operable NMFS-approved Vessel Monitoring System (VMS) and without complying with VMS requirements. A \$15,000 NOVA was issued, and the case settled for \$10,000. [See Charged Cases, Item 3, from January-April 2021 report.]
- AK2101775; F/V Sentinel Owner/Operator Arseny Polushkin was charged under the Magnuson-Stevens Act for interfering with and harassing authorized officers during the lawful discharge of their duties. - 3. NE1906654; F/V Stormy Elizabeth Owner William J. Mulvey and Operator Edward D. Coughlan were charged jointly and severally under the Atlantic Coastal Fisheries Cooperative Management Act with landing 116 undersized and four v-notched American lobsters. Both were also charged under the Magnuson-Stevens Act with failing to complete a vessel trip report prior to entering port. A \$12,500 NOVA was issued, and the case settled for \$11,250. [See Charged Cases, Item 10, from May–August 2021 report.]
- 4. NE2000188; F/V Reelin N Dealin Respondent Jacob G. Hiles was charged under the Magnuson-Stevens Act with selling a swordfish without a valid permit and/or transferring a swordfish for a commercial purpose after it was landed by the owner of a vessel not permitted to do so. A \$6,742 NOVA was issued, and the case settled for \$1,992. [See Charged Cases, Item 11, from May–August 2021 report.]
- 5. NE2103813; F/V Reel Screamer Owner/Operator Joseph B. Acito was charged under the Atlantic Striped Bass Conservation Act with possessing two Atlantic striped bass in the exclusive economic zone. A \$2,000 NOVA was issued, and the case settled for \$1,500. A Notice Of Proposed Forfeiture was also issued for the proceeds (\$283.80) of the violation.
