- 1. AK1708652; F/V Vaerdal Crewman Justin Williams was charged under the Magnuson-Stevens Fishery Conservation and Management Act (Magnuson-Stevens Act) with harassing a female fisheries observer. A \$24,000 NOVA was issued.
- 2. AK2100328; George C. Woodin A charter vessel angler exceeded the IPHC 2019 annual limit of four Pacific halibut in Area 3A by two fish. A \$400 NOVA was issued.

NE2106749; F/V Two Dukes – Owner Two Dukes, Inc. and Operator Erick Hartnett were charged jointly and severally under the Atlantic Coastal Fisheries Cooperative Management Act with the possession of 72 undersized lobsters, seven v-notched lobsters, and four berried lobsters.
